- A: In the RFP on page 5: "Currently, Floyd County Public Schools' section 125 plan year is September 1 August 31. It is the desire of the school division to implement a short plan year for the month of September in order to transition to a plan year for October 1 September 30 which will coincide with the plan year of our group healthcare benefit programs."
 - *The plan year for our group healthcare programs (medical, dental and vision) is October 1 September 30.
 - *Currently, the plan year for our Section 125 plan is September 1 August 31. We would like to change the plan year to October 1 September 30.
- Q: Who does AFLAC use for your current flex spending programs?
- A: Wageworks
- Q: What are the monthly per employee fees charged by AFLAC for Section 125 plan administration and flex spending accounts?
- A: Currently, the school division does not pay any fees for either Section 125 administration or fees on any flex spending accounts.

- A: Flexible Benefit Administrators (FBA); The monthly fee charged by FBA is \$2.35 per participant.
